**ADMISSIBLE WORK:** work in painting, sculpture, graphic arts, mixed media, photography and ceramics are admissible.

All original prints, including those digitally produced, must be numbered in editions.

Work should be handed in to THE DANCE HALL, CONDUIT HILL, RYE, TN31 7LE ON **THURSDAY 29TH JULY 4-7PM**  
ALL WORK MUST BE FOR SALE. Non-members work will only be received at the time stated.

**INADMISSIBLE WORK:** *printed reproductions of original artworks, giclee copies or reproduced editions of original drawings or paintings.*

All original prints including those digitally produced must be numbered in editions (a digital print is only considered an 'original print' if it was created by the artist to be realised specifically as a print in this specific format). Work in excess of 12 sq.ft. or 1.5 sq.mtrs including frame, will be hung only at the discretion of the Hanging Committee.

**LABELLING:** all work to be labelled with **title, price, medium, name and address of artist.**

**Pictures should be framed, labelled on the back and fitted with a second label. This label should contain all the information on a string long enough to hang over the front of the picture for cataloguing the works after they are hung.**

Printmakers and photographers should also include details of the availability and price of any unframed prints on the hanging label. Pottery and 3-D work must be freestanding and clearly labelled with the artist's name, title, description, medium and price on each item.

The artist's name should be written on the form as it will appear on the exhibition label.

D-RINGS ONLY are to be fixed to the back of frames to avoid damage when stored. The Hanging Committee hope to be able to hang all of the works selected, but only within the constraints of the space available and the compatibility of the works.

Non-members may submit 1 work. Submission fee: **£5.00**. This applies to both 2d and 3d artists.

There is no additional hanging fee and non-members must be living within a 15 mile radius of Rye.

**COMMISSION FEES on sales:**

Non-members 35% whether the sale be effected by the Exhibition Authorities or the Exhibitor.

ACCEPTED WORK MAY NOT BE COLLECTED OR REMOVED DURING THE EXHIBITION. WORK NOT ACCEPTED MUST BE COLLECTED ON **WEDNESDAY 4TH AUGST 4-7P.M.**

ARTISTS WILL BE RESPONSIBLE FOR INSURING THEIR OWN WORKS AGAINST LOSS OR DAMAGE.

The society, whilst taking great care of work submitted, will not be held responsible for any loss or damage incurred during the exhibition or in transit.

BOTH THE ATTACHED FORMS ARE TO BE SUBMITTED WITH THE WORKS, NON-MEMBERS MUST PAY THEIR £5 FEE, AND BRING AN S.A.E. SIZE C5 FOR NOTIFICATION. THE SELECTION COMMITTEE'S DECISION SHALL BE FINAL AND EACH ARTIST WILL BE NOTIFIED. NO CORRESPONDENCE WILL BE ENTERED INTO REGARDING THE SELECTION.

Work must be removed on **AUGUST 31ST BETWEEN 11-1P.M.** For security reasons work will only be returned on production of the receipted collection form. EXHIBITORS ARE RESPONSIBLE FOR THE REMOVAL OF ALL THEIR WORK, BOTH SOLD AND UNSOLD, ON COLLECTION DAY **AUGUST 31ST** IN THE EVENT OF A WORK BEING SOLD BUT NOT PAID FOR IN FULL BY COLLECTION DAY, THE WORK WILL BE RETURNED TO THE ARTIST ONLY, WITH FULL DETAILS OF THE OUTSTANDING TRANSACTION.

The Society will not be held responsible for works not collected at the specified times on **AUGUST 31ST.**
