CHECKLIST - Before you hand in your form and artwork, please note:

- Read the regulations below and sign the form on page 1. Keep your collection form on page 3 to collect unselected work **OR** to collect unsold work at close of show.
- Submit up to 2 works of art for 2-D artists, and up to 3 works for 3-D artists. Works must have **2 LABELS** attached. Attach 1 label firmly on the back. The second label please attach on the front hanging from a long piece of string to help with cataloging & hanging. Each label must have:-
 - **artist's name, email address (CLEARLY WRITTEN) and contact number**
 - **the title, medium and sale price of the artwork**
- All pictures must be framed. D-Rings and string only are to be fitted to framed work.
- You must live within a 15 mile radius of Rye (view the map on our website, on the 'how to become a member' page).
- Submission fee (you can pay by card or in cash). This fee is £10 per artwork.
- Please note if your work is **NOT** selected you will be notified by email (or phone call if you do not have email) and your work must be collected from the Community Centre on Wednesday 31st July, between 5-7pm. **Please bring the Receipt & Collection form.**
- At the end of the show run, **UNSOLD** work must be collected on Tuesday 27th August, between 11-2pm from the Community Centre. **Please bring Receipt and Collection Form**

REGULATIONS:

- All Works must be for sale. Selected works may not be removed during exhibition.
- Admissible works: works in **painting, sculpture, graphic arts, photography and ceramics are admissible**. All original prints must be numbered in editions. Inadmissible works: printed reproductions of original artworks, giclee copies or reproduced editions of drawings/paintings.
- Works in excess of 12 sq. feet or 1.5 sq. metres including frame will not be accepted.
- Commission fee on sales is 35% whether the sale is affected by RSA or the exhibitor.
- Artists will be responsible for insuring their work against loss or damage.
- The selection committee's decision is final and no correspondence will be entered into.
- If selected work is sold, but not yet paid for, the artist will be responsible for collecting and arranging delivery to the buyer. ALL work must be collected on **Tuesday 27th August, 11-2pm.**
